We will be joined by two guests at Monday's meeting:

#### 9:30AM - 10AM

Jeffery Reister from the Colorado Attorney General's office will join us to discuss HB21-1282 - This bill seeks to regulate non-bank mortgage servicers at the Department of Law by requiring notification to the Department when they are doing business in Colorado to ensure compliance with existing federal law, such as the Truth in Lending Act (TILA) and the Real Estate Settlement Procedures Act (RESPA). By aligning with federal law, we are providing additional protections without additional burden on industry. With this new authority, the Attorney General will be better positioned to reduce the negative impact the pandemic is having on the housing market and protect consumers in the future when their home may be at risk due to bad behavior.
