REVIEW OF COMMITTEE PROCEDURES

The committee will discuss a bill and decide whether to keep it on our list for consideration of a position at the next meeting. ***Remember, you must be a Member of the Colorado Center for Aging to vote on bills.***

We need this position filled:

The committee will seek a volunteer to take responsibility to follow each bill through the committee hearings and discuss it at the CCA Advocacy Committee Meetings.

Bills will be reviewed and considered for a position of Support, Strongly Support, Oppose, Strongly Oppose, Amend, or Monitor. The committee also may take a position of Support with Amendments or Oppose with Amendments or Strongly Oppose.

Bill Review and Voting on Positions

- At this meeting we will be reviewing the bills in our CCA Bill Tracker and voting on positions and/or keeping them in our Bill Tracker.
- ***As of Feb 5th we have forty-five bills in our CCA Bill Tracker and that is too many to follow.*** We will have to make some difficult decisions at this meeting and delete some of the bills.
- To make the task of reviewing the bills more efficient, we need all members to review the bills before the meeting – see instructions below

Reminder about Reviewing the Bills

We have forty-five bills in our CCA Bill Tracker. We cannot follow this many bills, so we need to focus on the bills that have the most impact on older adults.

Please review the list of bills and come prepared to share your top bills that you think we should follow and become involved with. Remember that we will need volunteers to step forward to follow each of the bills we are tracking. Be prepared to get involved in the bill tracking.
