REVIEW OF COMMITTEE PROCEDURES

*The committee will discuss a bill and decide whether to keep it on our list for consideration of a position at the next meeting. **Remember, you must be a Member of the Colorado Center for Aging to vote on bills. Every bill we follow must have a volunteer who will take responsibility to follow each bill through the committee hearings and discuss it at the CCA Advocacy Committee Meetings.***

Bills will be reviewed and considered for a position of Support, Strongly Support, Oppose, Strongly Oppose, Amend, or Monitor. The committee also may take a position of Support with Amendments or Oppose with Amendments or Strongly Oppose.

BILL REVIEW AND VOTING ON POSITIONS • We have been asked to discuss HB22-1278 Behavioral Health Administration. We will have a discussion about this bill at Monday’s Meeting. Here is a link to the bill [HB22-1278: Behavioral Health Administration | CCW \(coloradocapitolwatch.com\)](#)
